1. Bidding Documents can be obtained from the office of the Medical Superintendent, GMH from 25/08./2022. Upto 11 /09/2022 .during office / working hour which will be provided after request on firm letter on cash payment amounting to Rs.1000/- (Non-Refundable) under KPPRA Rule 33(5).
2. As per Clause 37(A) of KPPRA Rules, all bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRRA).
3. All bids must be accompanied by a bid security in shape of call deposit equal to 2% of the estimated cost.
4. The firm must be on FBR Active Tax Payer List and last year Tax return must be attached with the Bid.
5. The firms must provide detail of NTN, Sales Tax Number , Income Tax Number ,professional Tax registration to GMH
6. Sealed bids should reached through courier service before prescribed time and Date and will be opened on the same date.
7. All contractors/ firms are bound to follow the KPPRA rules.
8. Bid must be valid for 30 Days after last date of submission.
9. Quotations received without specifications shall be rejected.
