The sealed Tenders are invited from the eligible firms / bidders in accordance with KPPRA Procurement Rules 2014 for the Drilling of water Bore Well at Government Maternity Hospital Peshawar on single stage two envelope procedure for the below mentioned work.

Terms & Conditions:-

- Tender form along with BOQ can be obtained from the office of the Medical Superintendent, GMII
 during working hours which will be provided after request on firm letter head after payment of PKR
 1000 / Cash.
- 2. As per Clause 37(A) of KPPRA Rules, all bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA).
- 3. All bids must be accompanied by a bid security in shape of call deposit equal to PKR 68000.
- 4. The firm must be on FBR Active Tax Payer List,
- 5. All the firms must be registered with PEC (Pakistan Engineering Council)
- 6. The firms must provide detail of NTN, Sales Tax Number, Income Tax Number and Professional Tax Number or other taxes to GMH
- Sealed bids must be sent through Registered Mail/Couriers Services should reached on opening date and will be opened on the same date.
- 8. The tender shall be processed according to "Above/below system" based on the Market Rate System 2022-2nd BI ANNUAL.
- 9. All contractors/ firms are bound to follow the KPPRA rules.
- 10. No tenders are acceptable through Fax/by hand.
- The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security
 2% only of Engineer Estimate.
- 12. The contractors quoting their bids more than 10% below upto 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.
- 13. [Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's Estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis]¹. In case of more than 20% below bids, if the bid is not accompanied

- by the detailed rate analysis and *I* or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
- 14. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
- 15. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- 16. All relevant taxes will be deducted from the contractors Bills.
- 17. If there is un-expected holiday announced by the Government on the opening date of the tender than the tender will be placed on notice board on next working day.
- 18. Any addition made in terms and conditions in the NIT advertised will be implemented as per KPPRA Rules.
- 19. Evaluation of Technical Proposal will carried out with pass / fail threshold in passing all the field including PEC registration in category c-6 & above, Tax payer proof, technical personnel, required equipment, financial status with Bank Statement of past 1 year (up to June 2022), past 1 year auditors reports (up to June June 2022), work orders of drilling of water Bore Well in previous 5 years, performance satisfaction certificate for previous contracts, managerial capabilities, litigation status etc. Evaluation criteria in this regard can be obtained from office of the undersigned on any working day in office hours. Technical Bid and financial Bid should be in sealed envelope clearly marked "Technical Bid" and "Financial Bid" addressed to the Medical Superintendent Government Maternity Hospital Peshawar through Pakistan Post / UMS / Courier before closing time.
- 20. All the rates should be printed on firm original letter head, stamped & signed, all the documents should be stamped & signed. No hand written rates or bids will be accepted.
- 21. An affidavit /non black listing certificate on original stamp paper of judiciary attested and updated from 31/07/2022 month must be attached.
- 22. Bid Validity 60 days from date of Bid closing Date .
- 23. The competent Authority has the right to reject all or any bids under Rule 47 of the KPPPRA Procurement Rules 2014 after assigning valid reasons.
